Homelessness & Public Safety Resources for Employers and Employees

Businesses in our community have experienced increased incidents of trespassing, unsanctioned camping, theft, abandoned debris, vandalism, and property damage. This resource was developed by the Eugene Chamber Business Leaders Task Force on Homelessness with support from the City of Eugene, to provide local businesses with tools to communicate with our unhoused neighbors, and clarification of rights when local businesses become victims of crimes.

Trespassing

Deterrence First:

- Post "no trespassing" signs on your property
- All businesses should file a Trespass Letter of Consent with Eugene Police: eugene-or.gov/2027/Trespass-Letter-of-Consent

If someone is actively on private property without permission:

- If possible, communicate clearly to the person they are trespassing and that you need them to vacate your business premises
- If the trespasser refuses to leave, call Eugene Police: 541-682-5111 (non-emergency) or 9-1-1 (for emergency); tell dispatcher that you've told the trespasser they are trespassing and that they refuse to leave, tell dispatcher that you have a Trespass Letter of Consent on file with Eugene Police (see above for instructions on how to file). CAHOOTS is dispatched through Eugene Police (typically by calling the non-emergency number). Response times vary greatly.



Vandalism, Theft, Property Damage

Deterrence First:

If a criminal incident occurs:

Report <u>all incidents</u> online to Eugene Police ceapps.eugene-or.gov/epdcoplogic/ You can upload photos and quickly get a case number for insurance or reference purposes.



Unsanctioned Camping

If unsanctioned camping has occured on your property:

- Report unsanctioned camping: eugene-or.gov/4902/Report-Concerns
- Report unsanctioned vehicle camping in the right-of-way: eugene-or.gov/2779/Report-a-Vehicle-Camping-or-Parking-Prob
- Report debris or waste on adjacent public property/right-of-way (sidewalk, streets, planting strips): eugene-or.gov/1776/Maintenance-Service-Request
- Call Eugene Police to report camping in adjacent planting strips (541-682-5111), or designate an agent to report for them by filling out the form at: eugene-or.gov/4410/Planting-Strip-Designated-Agent-Process

Other Tips for a Safe Response

- 1. Assess the situation from a safe distance prior to engaging with any individuals on your property.
- 2. Odds are, this won't be a one-off interaction, so if it feels safe, it's good to establish a friendly relationship. Introduce yourself. Ask for the person's name.
- 3. Politely ask them to leave using sincere empathetic language that deflects the request from yourself to a third party (e.g., the property owner asks them to leave, even if that person is you). This reduces the power-dynamic, and will help in future interactions.
- 4. Let them know where they can be, as opposed to only where they cannot be.
- 5. If they are not cooperative, tell them you are going to call the police, but would rather not. Avoid confrontation and keep a safe distance if you feel threatened in any way. Call Eugene Police non-emergency 541-682-5111 first, and if they become disruptive or dangerous call 911.
